PRESIDENT'S REPORT



Dear QIA Members,

As the deprivations caused by Covid show signs of ameliorating, I would like to report on the progress the QIA has made over the last financial year.

Director Mark Morrissey and his wife, Narelle, attended the Darling Downs Irish Club Annual Dinner in Toowoomba as the guests of the Darling Downs Irish Club.

We held a fine Christmas Party at Wests Rugby Club in December 2021.

After the St Patrick's Day Parade had been cancelled in 2020 and 2021, it was a wonderful relief that the Parade made a triumphant return this year. The Queensland Irish Association was proud of its contribution – a 1910 Fiat Truck, bearing a very handsome-looking St Patrick. Thanks to Mark Morrissey for securing this historic vehicle for the parade, and to its owner, Ian Fordyce, for driving the truck, and Jim Kendall for playing the role of St Patrick so well.

The QIA Pipe Band was, as usual, at the head of the Parade. The ladies from the Tigh Gaelach Dining Club adorned the vintage cars in the Parade, and the QIA Dancers performed brilliantly throughout.

Covid was responsible for the cancellation of the St Brigid's Dinner this year. Margaret Stacey has included details of the St Brigid's Dinner for February 2023 in this year's annual report. It promises to be an outstanding function. It will be held on Saturday, 4 February 2023 at "Royal on the Park", 152 Alice Street, Brisbane.

The highlight of this year was the St Patrick's Eve Dinner, held at the Pullman Hotel, King George Square, Brisbane on 16 March 2022. It was undoubtedly one of the most brilliant dinners for many years.

I welcomed, on your behalf, a galaxy of outstanding guests – Anthony Albanese (in March 2022, the Leader of the Opposition, but now the 33rd Prime Minister of Australia), Annastacia Palaszczuk, the Premier of Queensland, our co-patron, the Ambassador of Ireland to Australia, Tim Mawe, Bishop Tim Norton SVD, representing our co-patron, Archbishop Mark Coleridge, Martin Daubney, a retired Supreme Court Judge and currently the Chancellor of the Australian Catholic University, and Siobhan Dooley, whose Toast to Australia, our Nation, was preceded by a speech that was both moving and profound. The Rev Dr David Pitman AM also attended.

The evening's top billing went to Hildegard Naughton TD, the Irish Minister for Transport, who spoke of the suffering of the people of Ukraine as a consequence of the Russian Invasion. The Minister was an opera singer before her appointment to the Irish Parliament, and brought the house down with an a capella rendition of "Nella Fantasia".

At the Dinner, His Excellency the Ambassador of Ireland presented Life Membership of the QIA to Margaret Stacey and Mavis Williams for outstanding service over decades to the Association.

A full report of this historic St Patrick's Eve Dinner is contained in this Annual Report, compiled by Robert Ward, a Life Member and a former President of the QIA, and the backbone of the organization behind the St Patrick's Eve Dinner.

Again, the QIA Dancers have performed very well, and Kate Hartley's account in this Annual Report shows why Irish dancing has such a valued place in Ireland's cultural contribution to Australia.

The QIA has, through the Queensland Irish Heritage Fund, been able to assist the QIA Dancers, first in helping fund the May Feis, now in its 60th year, and also supporting the State Dancing Championships by funding Bronze Sponsorship of the championships. The QIA Perpetual Trophy is awarded to the premier dancer in the open section of the Ladies Championship.

The QIA Pipe Band represents perhaps the most public face of the QIA, though it is a separate entity. I am very pleased to report that, through the efforts of Director David O'Farrell, the QIA has solved a problem that has worried the QIA Pipe Band for many years – a suitable home for the band to practice. The QIA has entered into a sub-lease of premises at Morningside for two years, with an option for a two further years, and will meet the rental and all outgoings, so that the Band will have exclusive use of most of the sub-lease area 24/7, at no cost to the QIA Band. This is a significant outlay for the QIA, but gives a welcome security to the Band.

The QIA, during the financial year just gone, conducted regular monthly functions at the Grand Central Hotel, which was, and still is, the venue for the monthly Tara Hall Dining Club. The President Tony Pisani's short report is included in the Annual Report.

The QIA Pipe Band provided entertainment at most of the monthly functions at the Grand Central, but a change of ownership of the hotel from Jazz Mooney has meant that the venue for the monthly functions has had to change.

As Michelle Fitzpatrick's report in this Annual Report shows, the Tigh Gaelach Ladies Dining Club continues to flourish.

Bloomsday in Brisbane this year was a great success. A report appears in this Annual Report. The QIA received generous support from the Embassy of Ireland in Canberra for this outstanding cultural event.

I have already indicated that funds from the restored Queensland Irish Heritage Trust Fund have been used to assist the QIA Dancers in promoting Irish dancing. The QIHT Fund has deductible gift recipient status with the Australian Tax office.

The Trust constituting the QIHT Fund was set up in 1997 by the efforts of former President, current Life Member Robert Ward, for the purpose of obtaining tax deductibility for donations made to the Fund, for the purpose of advance its aims.

This may be of particular interest to Senior Members of the Association, those of more than 30 years' membership. Senior Members are not obliged to pay the member's annual fee, but are encouraged to make a donation in lieu. This can now be done through the QIHT Fund, which

has the consequence of securing a tax deduction for the value of the donation.

I urge all Senior Members to make a donation of at least the amount of the Annual Subscription, currently \$20, to the QIHT Fund and a receipt will be issued which will enable a tax deduction to be claimed.

As I said last year, if anyone has a spare million or two, a donation to the Fund would go a long way to assisting the acquisition of suitable premises for the QIA.

I want to thank all Members of the Board of the Queensland Irish Association for their great (and entirely voluntary) contributions over the past year. In particular, I would like to thank one Director, Mark Morrissey, who has served with distinction as a Director, particularly in connection with the acquisition of the 37 Baxter Street premises, and his continuing efforts to secure a tenant for the ground floor of Baxter Street. Mark's contribution to the QIA has been herculean, and while he will continue to assist, poor health has meant he did not seek re-election at the recent elections of the QIA.

I also want to thank each of you, the Members of the Queensland Irish Association, for your continued loyalty and support. As this Annual Report shows, the QIA is a vibrant celebration of our Irish Heritage and our good fortune of being of Irish descent.

My thanks and good wishes to you all.

A capacity crowd of QIA members and guests were in attendance, and the Presidential Ballroom was filled with a celebratory ambience which contributed to another special occasion. St Patrick's Feast Day was previewed with cultural camaraderie, music, dance and song, with wonderful speeches and anthems, as well as appropriate refreshments.

The toast to “Australia Our Nation” was presented by Siobhan Dooley from the well known Brisbane Irish Dooley family. She delivered a detailed homage to strong Irish-Australian women who had made such remarkable and effective contributions to the fabric and development of Australia. It was a very informative address which should stimulate further research into this area of Irish-Australian history.

The undoubted highlight of the occasion was the address by visiting Irish Minister, Hildegard Naughton TD. In proposing the toast to “The Day We Celebrate”, she tempered the exuberance of the gathering by pointing out the lack of opportunity of others to celebrate, and whose situation should not be forgotten in the moment, particularly the plight of those in the Ukraine. As an accomplished soprano, she reinforced her theme with a fabulous rendition of “Nella fantasia” and then led the singing of the Irish National Anthem to a standing ovation.

Chancellor of the Australian Catholic University (ACU) Honourable Martin Daubney AM responded to both toasts with his usual grace and flair.

Outstanding addresses were received from the Honourable Anthony Albanese, Leader of the Federal Opposition, the Premier of Queensland, Annastacia Palaszczuk, Mr David Janetzki representing the Leader of the State Opposition and Cr Vicki Howard, representing the Lord Mayor.

Rev Dr David Pitman AM once again gave the final address with a reflective and entertaining message of gratitude and hope.

The Queensland Irish Association Irish Dancers and QIA Pipe Band gave another superb display of Irish culture and the Bob Mac Trio led the gathering in community singing throughout the evening.

Special thanks must go to Master of Ceremonies Graham Moloney, for once again ensuring the professional running of an extremely busy programme. Especially significant, after four decades of attending this function, was the inclusion in his closing remarks that “this will be a night that will live in your memory as one of the finest evenings that has ever been held by the Queensland Irish Association on St Patrick’s Eve. It is almost without parallel”.

Sincere thanks are due to all those mentioned above, as well as the management and staff of the Pullman Brisbane Hotel, all the members of the St Patrick’s Eve Dinner Committee, and others for their contributions to the success of the 2022 Dinner.



There was great hope that we could return to what we once knew as normal and while there were some strides towards that we were still prepared to change our plans at short notice as was still required.

It was wonderful to be able to return to more face-to-face classes and to return to our team classes which have been an integral part of QIA Dancers over the majority of our history. In spite of the disruptions that COVID presented our numbers still continue to grow particularly in our younger age groups and our Adult classes. We welcome dancers of all levels and ages to come and be part of our group.

The ethos and goal of our group remain unchanged, we aim to keep the Irish Culture alive through dance, and are happy to share our talents with the wider community when given the opportunity. We may not have had the same number of opportunities to show our talents through events and displays but when we have had the chance we have grabbed it. It was wonderful to be out together for the 2022 St. Patrick's Day Parade after a 3 year hiatus. Our thanks to the organisers of any events that we have had the pleasure of performing at, your continued support is greatly appreciated.

The group evolves and changes with the years as we have many dancers that are now reaching the end of their journey as dancers and looking towards becoming Teachers in their own right. It is such a privilege as a Teacher to watch these dancers who start dancing at the age of 4 or 5 blossom into confident and talented performers and adults.

We have continued our connections with Brothers Rugby Union Club at all be Albion during the week and at the Mary Mac Centre at Annerley on weekends. Their continued support and flexibility in times that have been uncertain is greatly appreciated. The support of these venues has meant that we have seen more increases in the numbers of Beginner dancers that we are welcoming into our group which ensures the ongoing future of the group. We also have a growing group of Adults joining our classes for fun and fitness.

The competition landscape was again a bit different to previous years, while there were more opportunities to compete locally, with lockdowns still regularly being enforced in other States, the opportunity to travel and meet up with our interstate friends did not occur. The Australian International Oireachtas (previously held at Royal Pines) moved to an online format which was a brand new undertaking for our dancers. Our National Championships were again cancelled due to the inability of many dancers from around Australia to come together in one venue.

Our State Championships scheduled to be held in August 2021 were finally able to be convened in October, and the delay allowed us to include team events in the Championships. There are times when everything aligns and all the hard work pays off. Our teams were extremely successful at the State Championships winning 8 team titles across the weekend. There was much excitement when our youngest dancers, dancing in their first State Championship, won

the Progressive Ceili section. Our older dancers shone winning the other 7 events some in sections that we have not been successful in for a few years. I would also like to acknowledge our one solo Champion. Ellie Barbagallo won the 18 years Ladies' section (her 6th consecutive Title) and her last as she retires from dancing to study.

This year marked our 60th May Feis, a huge achievement and one that we celebrated with dancers, friends and families past and present. It was a great to be able to come together and a wonderful celebration of dance at Goold Hall at Villanova College. Our thanks to the QIA Irish Heritage Trust that made a financial contribution enabling us to have live music throughout the competition weekend and a celebration Ceili that saw people coming together to dance and celebrate late into the evening. A huge thank you also to all the members of our QIA Dancing Family that come together to volunteer their time and energy to make this event such a success.

Thanks to the members that take on roles to keep our group moving ahead. As an incorporated association we are a bit unique in the dancing world and the donation of expertise and time that these people give to the group is enormous. We extend thanks and gratitude for all that they have done and the support that they give to our Teaching team to allow us to follow our mission of keeping the Irish Culture alive through dance.

In true Bloomsday spirit,the gathering was welcomed at Gilhooleys in the city , where the celebrations of the centenary continued.


Bloomsday in the City is an important event for the Queensland Irish association and we will be back in 2023 to begin the next century!



The financial statements cover Queensland Irish Association Friendly Society Limited as an individual entity, incorporated and domiciled in Australia, a Company Limited by Guarantee.

The financial statements were authorised for issue on 2nd November, 2022 by the Directors of the Company.

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Directors have prepared the financial statements on the basis that the Company is a non-reporting entity because there are no users who are dependent on its general-purpose financial statements. These financial statements are therefore special purpose financial statements that have been prepared in order to meet the requirements of the *Corporations Act 2001*. The Company is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the *Corporations Act 2001* and the significant accounting policies disclosed below, which the Directors have determined are appropriate to meet the needs of members. Such accounting policies are consistent with the previous period unless stated otherwise.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs unless otherwise stated in the notes. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise. The amounts presented in the financial statements have been rounded to the nearest dollar.

(a) Income Tax

In the opinion of the Directors, the Company is exempt from all forms of income tax under Section 50-1 of the *Income Tax Assessment Act 1997*. Accordingly, no provision for income tax has been provided for.

(b) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is recognised immediately in the statement of profit or loss.

Where the future economic benefits of the asset are not primarily dependent upon on the asset's ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of a class of asset, the entity estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Where the impairment loss on a revalued asset is identified, this is debited against the revaluation surplus in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that same class of asset.

(c) Provisions

Provisions are recognised when the Company has a legal or constructive obligation, as a result of past events for which it is probable that an outflow of economic benefits will result, and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(d) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position.

(e) Revenue and Other Income

Non-reciprocal grant revenue is recognised in the statement of profit or loss when the entity obtains control of the grant, and it is probable that the economic benefits gained from the grant will flow to the entity and the amount of the grant can be measured reliably.

If conditions are attached to the grant which must be satisfied before it is eligible to receive the contribution, the recognition of the grant as revenue will be deferred until those conditions are satisfied.

When grant revenue is received whereby the entity incurs an obligation to deliver economic value directly back to the contributor, this is considered a reciprocal transaction and the grant revenue is recognised in the statement of financial position as a liability until the service has been delivered to the contributor, otherwise the grant is recognised as income on receipt.

Queensland Irish Association Friendly Society Limited receives non-reciprocal contributions of assets from the government and other parties for zero or a nominal value. These assets are recognised at fair value on the date of acquisition in the statement of financial position, with a corresponding amount of income recognised in the statement of profit or loss.

Donations and bequests are recognised as revenue when received.

Interest revenue is recognised as it accrues using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Revenue from rendering of a service is recognised upon the delivery of the service to the customers. All revenue is stated net of the amount of goods and services tax (GST).

(f) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). Receivables and payables are stated inclusive of the GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

(g) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from donors and any outstanding grant receipts.

Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(h) Comparative Figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year. When an entity applies an accounting policy retrospectively, makes a retrospective restatement or reclassifies items in its financial statements, a statement of financial position as at the earliest comparative period must be disclosed.

(i) Accounts Payable and Other Payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the Company during the reporting period which remain unpaid. The balance is recognised as a current liability with the amount being normally paid within 30 days of recognition of the liability.

0) Critical Accounting Estimates and Judgements

The Directors evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Company.

Key Estimates

(i) Impairment

The Company assesses impairment at the end of each reporting period by evaluating conditions and events specific to the Company that may be impairment triggers.
